*Candidates for Pledged Party Leader and Elected Official (PLEO) Delegate and/or Pledged At-Large Delegate must file this declaration of candidacy form with the Chair of the Michigan Democratic Party by **5:00 pm on Monday, May 18, 2020**. Forms will be accepted through email (cjensen@michigandems.com), mail (606 Townsend, Lansing, MI 48933), or using an [online version here](#). Candidates must also be members of the Michigan Democratic Party by **5:00 pm on Monday, May 18, 2020**. There are no exceptions. Presidential candidates have the right to approve or reject candidates for delegate or alternate pledged to them.*
