

# Senate District 24

---

Governor Whitmer's plan for COVID-19 relief would directly help Michiganders. Congress passed a bipartisan funding bill that sent much-needed dollars to Michigan to help us return to normal. The Governor's plan includes:

- Funding for Michigan schools to help return to in-person learning.
- Rent and mortgage assistance to keep Michiganders in their homes.
- Restored unemployment as Michigan returns to work.
- Food assistance for Michigan families who are struggling to buy groceries.

**More than \$3.3 billion of that federal funding is being held** in the Legislature.

## **Here's what that means for Senate District 24:**

### **Schools**

**More than \$32.4 million in unallocated funds for public schools affecting 39,922 kids in grades K-12. That amounts to \$811.83 per student in District 24 schools.**

\$32,409,690 that would help schools in District 15 pay for COVID-19 testing, academic support, social and emotional support for students, and ongoing costs related to the pandemic is currently sitting in the Michigan State Treasury, including:

- \$589,977 for Charlotte Public Schools
- \$535,545 for Eaton Rapids Public Schools
- \$630,364 for Grand Ledge Public Schools
- \$1,385,740 for Owosso Public Schools
- \$507,450 for St. Johns Public Schools

### **Renters and Homeowners**

Even before the pandemic began, **33% of renters in District 15 and another 13% of homeowners struggled to afford their monthly housing payments.**

The legislature is withholding **\$339 million** that was meant to keep Michigan families safely in their homes.

### **Unemployed Workers**

Governor Whitmer's plan includes a restoration of unemployment benefits back to 26 weeks. As of March 2021, there are approximately **3,700 active unemployment claims in Clinton County, 6,500 in Eaton County, 21,900 in Ingham County, and 4,700 in Shiawassee County.**

- 4.8% unemployment in Clinton County, up from 3% in January 2020
- 5.7% unemployment in Eaton County, up from 3.3% in January 2020
- 6% unemployment in Ingham County, up from 3.2% in January 2020
- 6.7% unemployment in Shiawassee County, up from 4.4% in January 2020

Unemployed workers in District 24 could receive **\$2,172 more in benefits** if the Legislature restored the program back to 26 weeks.

### **Families Needing Food**

Even before the pandemic began, many families in District 24 needed help to buy enough food.

- In Clinton County, 33% of K-12 students receive free or reduced price school lunches. 20% of children ages 4 and under receive WIC assistance.
- In Eaton County, 42% of K-12 students receive free or reduced price school lunches. 37% of children ages 4 and under receive WIC assistance.
- In Ingham County, 48% of K-12 students receive free or reduced price school lunches. 48% of children ages 4 and under receive WIC assistance.
- In Shiawassee County, 48% of K-12 students receive free or reduced price school lunches. 50% of children ages 4 and under receive WIC assistance.

Michigan food banks and community food pantries have reported massive increases in the number of people needing help due to the pandemic. Many of those needing food assistance in District 24 have never used a food bank or food pantry before.

The Legislature is still sitting on **\$2.1 billion** in federal Supplemental Nutrition Assistance Program (SNAP) funding that would help these families and others in Michigan who continue to struggle to afford food because of the pandemic.
