## **MEETING WRAP UP**

The Independent Citizens Redistricting Commission has been gearing up for public hearings around the state to survey what communities of interest they should take into consideration. There will be public hearings around the state with the first one taking place in Jackson on 5/11/21 day at 6 pm. In a recent presentation by the University of Michigan, three commissioners (Douglas Clark, Rebecca Szetela, and Dustin Witjes) engaged in a discussion on ways to make sure public hearings are fair and effective. They expressed the excitement to get public insight on what they want to see out of the new districts and how the commission can be fair and address the gerrymandering issues Michigan has faced in the past.

Here's the new timeline they submitted to the Michigan Supreme Court.

The Republicans tried to do a "call to action" against the Commission's Voting Rights Act (VRA) Legal Counsel. The "call to action" was launched against Bruce Alderson because of his democratic background. They feel Alderson is a "Democrat Activist" and can't effectively be bi-partisan through the process. The commission voted to keep Bruce on. Below is the breakdown of the vote:

We have to keep a watchful eye out because the Republicans are not done with their assault on attacking anything the Commission does that doesn't fit their narrative. Word on the street is the GOP is going to try and argue to the Commission to bring on a second attorney (an identified Republican attorney) to "remove any appearance of partisan political bias."
