# Official Call to Convent for the Michigan Democratic Party's 2025 Spring State Convention

Saturday, February 22, 2025 at the Detroit Marriott at the Renaissance Center.

The Democratic Electors of the State of Michigan are hereby notified that by the direction the Michigan Democratic State Central Committee, the 2025 Spring State Convention of the Michigan Democratic Party will be held at the Detroit Marriott at the Renaissance Center on Saturday, February 22, 2025.

At the 2025 Spring State Convention, Michigan Democrats will gather by congressional district to elect district officers and members to the State Central Committee. Members MDP constituency group caucuses will meet and elect their leadership. On the Convention floor, Democrats will vote by congressional district to elect a Chair and two (2) Vice-Chai of the State Central Committee.

All members of the Michigan Democratic Party are encouraged to attend the 2025 Spring State Convention.

#### An Overview of the 2025 Spring State Convention Timeline

#### Saturday, December 7

The Michigan Democratic State Central Committee approves the Call to Convention.

#### Friday, December 13

The Michigan Democratic Party emails the Call to Convention to all members. This Call will also be available online at michigandems.com.

#### <u>Thursday, January 23</u>

Membership Deadline to be eligible to vote at the 2025 Spring State Convention. \*Does not apply to Precinct Delegates, Democratic Nominees, or Democratic Elected Officia

#### Thursday, January 23

Deadline for candidates seeking high level office at the MDP to file their candi High level office includes Chair and Vice-Chairs of the Democratic State Central Committee as well as Ch and Vice-Chair of a Congressional District.

#### Sunday, January 26

Deadline for MDP chartered constituency caucuses to request a meeting room and time at the Convention.

#### Saturday, February 8

Deadline to hold County and District Conventions.

#### Sunday, February 9 by 7 PM

Deadline for County and District Convention Chairs to submit resolutions and committee members to the MDP.

#### Tuesday, February 11 at 6 PM

Convention Credentials Committee meets virtually.

#### Tuesday, February 11 at 7 PM

Convention Rules Committee meets virtually to consider rules for the Convention.

#### Wednesday, February 12 at 6 PM

Convention Resolutions Committee meets virtually.

Wednesday, February 19 at 9 AM Credentialing Window Opens for the 2025 State Convention.

#### Saturday, February 22 at 2 PM

The credentialing window closes.

#### Saturday, February 22

Spring State Convention held at the Detroit Marriott at the Renaissance Center.

# I. 2025 Spring State Convention

The Michigan Democratic Party will hold its Spring 2025 Convention at the Detroit Marriott at the Renaissance Center on Saturday, February 22, 2025.

A. Schedule for Saturday, February 22, 2025

9:00 AM - 10:30 AM Constituency Caucus Meetings
10:30 AM - 12:00 PM Constituency Caucus Meetings
12:00 PM - 1:00 PM Lunch Break
1:00 PM - 2:30 PM Afternoon Congressional District Caucus Meetings 3:00 PM - Adjournment Convention Business

Beginning at 3:00 PM, the Convention shall convene for the purposes of:

1. Hearing a report on the number of Delegates

- 2. Hearing and voting on the report of the Rules Committee
- 3. Electing a Convention Chair
- 4. Selecting Convention Offic
- 5. Adopting Resolutions
- 6. Electing the Chair of the State Central Committee
- 7. Electing two (2) Vice-Chairs of the State Central Committee each of a different gend and race
  - 8. Conducting any other business which is proper and necessary.

The Convention is scheduled to adjourn on Saturday by 6:00 PM. The time of adjournment is tentative and subject to change.

The Democratic State Central Committee will meet immediately following adjournment of the State Convention to canvass and ratify the convention proceedings.

No business will be permitted on the Convention floor unless it is contained in this Call including a resolutions other than the resolutions that are properly placed before the Convention delegates by the Convention Resolutions Committee.

#### B. Constituency Caucus Meetings

Chartered constituency group caucuses may meet on Saturday, February 22, 2025 at either 9 AM or 10:30 AM at the Detroit Marriott at the Renaissance Center. These groups shall meet for such purposes as shall be proper and necessary. Many Constituency Caucuses plan to hold leadership elections in accordance with their bylaws. In order to obtain a room and meeting time, groups must submit their request for a meeting room via this form **no later than Sunday, January 26, 2025.** *Caucuses who fail to meet these requirements may be denied a room or time slot at Convention.* 

#### C. Congressional District Caucus Meetings

The delegates from each Congressional District will meet in caucus on Saturday, February 22, 2025 at 1:00 PM at the Detroit Marriott at the Renaissance Center for such purposes as shall be proper and necessary. The Caucuses shall adjourn by 2:30 PM.

The 2024 Democratic nominee for Congress (or their designee) shall serve as the temporary chair and shall convene and preside over the District Caucus at the State Convention until a permanent caucus chair is elected. In the event that the Democratic nominee or their designee is not present at the caucus at the hour for which it is called, their place as temporary chairperson shall be filled by t county chair from the county in the district having the largest number of votes in the 2024 general election for President.

The District Caucus shall elect as required under Rule 5.1.1 of the MDP Bylaws, a District Chair, Vice-Chair (of another gender from the Chair), Secretary, Treasurer and at least fifteen (15) members the District Committee, all who serve for two (2) year terms (or until their successors are duly elected) using a voting method as outlined in the Rules for Voting and Elections in the Michigan Democratic Party.

The District Caucus shall elect its allocated number of members and alternates to the State Central Committee for two (2) year terms using a voting method as outlined in the Rules for Voting and Election in the Michigan Democratic Party and according to the following allocation which is based on the November 5, 2024 vote count for President in accordance with Rule 6.1 of the MDP Bylaws.

# **II. Voting Privileges at the State Convention**

To be eligible to become credentialed and vote at the State Convention, a person must be a member of the Michigan Democratic Party for at least thirty (30) days prior to February 22, 2025, which is January 23, 2025.

To be eligible to vote during a Constituency Caucus meeting or Congressional District Caucus, a person must be a member of the Michigan Democratic Party for at least thirty (30) days prior to February 22, 2025, which is January 23, 2025.

\*According to rule 3.2.2 of the MDP bylaws, the thirty (30) day rule does not apply to Precinct delegates, Democratic elected officials, or Democratic nominees to partisan office. Instead, pr delegates, Democratic elected officials and Democratic nominees to partisan office may members of the Michigan Democratic Party at any point prior and until February 22, 2025 when they register at the State Convention.

#### A. Membership Deadline

- 1. Online membership applications are available here. To meet the deadline to be eligible to vote, an online contribution toward a membership or a free membership application must be submitted by 11:59 PM on January 23, 2025.
- Printable membership applications are available here. To meet the deadline to be eligible to vote, a hard copy of a membership application must be either: hand-delivered to Hart-Kennedy House by 5 PM on January 23, 2025 or mailed to Hart-Kennedy House, and postmarked no later than January 23, 2025.

 Individuals whose memberships are current as of January 23, 2025 but expire before February 22, 2025 are eligible to become credentialed and vote if they renew on or before February 22, 2025.

#### B. Credentials for the Spring State Convention

To be eligible to vote at the State Convention, a person must satisfy the membership requirements listed above. That member must also become successfully credentialed through the VOATZ electronic voting system in order to vote at the State Convention.

The credentialing window opens for the Spring State Convention at 9:00 AM on Wednesday, February 19, 2025. All eligible members will receive instructions from VOATZ via their email on file with t Michigan Democratic Party about how to download the VOATZ app for phone or tablet and become credentialed. In person credentialing will also be available on Saturday, February 22, 2025 starting at 9:00 AM. The credentialing window will close at 2:00 PM on Saturday, February 22, 2025.

Each member is responsible for verifying their own membership status. Each individual MDP member may confirm that they have satisfied the membership requirements and are eligible for credentia at the Spring State Convention. The MDP will not provide information regarding any individual member's membership status to any third party. The MDP will not provide information regarding the membership status of any individual in response to inquiries made by any candidate or candidate committee.

# III. County and District Conventions prior to the Spring State Convention

All counties are required to hold County Conventions. In addition, District Conventions shall be held in the 6<sup>th</sup>, 12<sup>th</sup>, and 13<sup>th</sup> Congressional Districts in order to ensure that MDP members residing in Wayne County are represented at these conventions.

In those counties comprising more than one Congressional District, each portion of the county within one Congressional District shall be considered a "county" and shall hold a convention.

#### A. Date, Time, and Place

All County and District Conventions across Michigan shall be held on or before Saturday, February 8, 2025. Each convention shall convene at the time and hour designated in the local Call issued by each County or District Committee.

The calls to County and District Conventions shall be issued to the delegates not less than fifteen (1 days before the Convention is held. If a County or District Convention is held on Saturday, February 8, 2025, then a call to convention must be issued by Friday, January 24, 2025.

#### B. Purpose

The purpose of the County and District Conventions shall be to elect members and alternates to the State Convention Committees and to consider resolutions to be forwarded to the State Party. Please see Appendix A for the 2025 State Convention Committee Suggested Allocations.

Each Congressional District shall be entitled to two delegates (one male and one female or not of the same gender identity) and two alternates (one male and one female or not of the same gender identity) on each of the following convention committees: Rules, Resolutions, and Credentials.

In order to be elected to a Convention Committee, a person must be a member of the Michigan Democratic Party for at least thirty (30) days prior to February 22, 2025, which is January 23, 2025.

Committee members shall be apportioned among the various Counties of each District. Care should be taken to ensure that the delegates and alternates in each district are balanced by gender.

The Chair of the County Conventions in the 1<sup>st</sup>through 5<sup>th</sup> and 7<sup>th</sup>through 11<sup>th</sup> Districts and the Chair of the District Conventions in the 6<sup>th</sup>, 12<sup>th</sup>, and 13<sup>th</sup> Districts are responsible for approving appointments to Convention Committees and submitting such appointments' names, emails and other contact information to the Michigan Democratic Party no later than 7:00 PM on Sunday, February 9, 2025.

#### C. County and District Convention Delegates

Delegates to County and District Conventions shall be members of the Michigan Democratic Party residing in the corresponding County or District whose membership was renewed at least thirty (30) days prior to the County or District Convention which if held on February 8, 2025, would be January 9, 2025.

\* Precinct Delegates, Democratic elected officials, and Democratic nominees to partisan o residing in the corresponding County or District may become members that day when they register at the County and District Conventions.

# **IV. State Convention Committees**

#### A. Credentials

Members of the Convention's Credentials Committee shall meet to discuss and receive training on the credentialing process for the State Convention. Members of the Credentials Committee are encouraged to help Democrats in their County and Congressional District become credentialed. The Committee's chair shall be designated by the Chair of the Michigan Democratic Party.

Members are invited to provide credentialing support at the State Convention on Saturday, February 22, 2025. Members of the Credentials Committee are asked to attend the Convention and assist with the credentialing process, which requires a comfortability with technology. Additionally, the Committee shall meet at the call of the Chair of the Michigan Democratic Party at the State Convention, if necessary.

#### **Credentials Committee Meeting**

Invitation: All members and alternates on the Credentials Committee will be emailed a zoom invitation to the meeting to the email contact provided by their Convention Chair to the MDP.

#### B. Rules

Members of the Convention's Rules Committee shall meet virtually to consider rules for the State Convention and to receive training in those rules and on proportional voting. The Committee's chair shall be designated by the Chair of the Michigan Democratic Party. The Committee will approve the final version of the rules that will oversee all business at the State Convention. Members of the Rul Committee are not required to attend the State Convention.

Invitation: All members and alternates on the Rules Committee will be emailed a zoom invitation to the meeting to the email address submitted by their Convention Chair to the MDP.

#### C. Resolutions

Members of the Convention's Resolutions Committee shall meet to consider resolutions approved at County and District Conventions and submitted for statewide consideration. The Committee's chair shall be designated by the Chair of the Michigan Democratic Party.

The Resolutions Committee will discuss, edit, and vote on a number of resolutions with the ultimate goal of creating a packet of resolutions that will go before the entire membership at the State Convention for a vote. Members of the Resolutions Committee are not required to attend the State Convention.

#### **Resolutions Committee Meeting**

Wednesday, February 12, 2025 6:00 PM - 10:00 PM Virtual via Zoom.

Invitation: All members and alternates on the Resolutions Committee will be emailed a zoom invitation to the meeting to the email address provided by their Convention Chair to the MDP. *If work is not completed by the scheduled time of adjournment, the Resolutions Committee shall reconvene on Thursday, February 13, 2025 at 6:00 PM.* 

#### D. Voting Privileges

In order to vote at these committee meetings, delegates and alternates of these committees must be members of the Michigan Democratic Party at least thirty (30) days before the convention committee meeting.

# V. Notice of State Convention

This Call shall be emailed to all Democrats who are Federal and State Elected Officials as well as District, County, Club, and Caucus Chairs on or before December 13, 2024.

Notice of the State Convention shall also be given to Michigan Democratic Party members via email, and the Call will be posted online at michigandems.com.

# VI. Candidates Seeking Election

Candidates seeking a high level office at the State Convention which includes Chair (1 position) Vice-Chair (2 positions) of the Democratic State Central Committee as well as Chair and Vice-Chair of a Congressional District shall be required to complete this form in order to file their candidacy with t Michigan Democratic Party. Candidates must complete the form **no later than January 23, 2025**, which is thirty (30) days prior to the February 22, 2025 State Convention. The form will also be provided on the party's website at michigandems.com. Failure to file timely will result in a candidate disqualificatio

Declared candidates seeking election for Chair (1 position available) or Vice-Chair (2 positions available) of the Democratic State Central Committee shall be eligible for consideration at the State Convention if they gather a number of signatures equal to ten percent (10%) of the statewide delegate vote or 1,270 signatures. If the number of required signatures exceeds the number of credentialed

delegates at the State Convention, the Credentials Committee shall meet to determine the number of required petition signatures.

All candidate petition signatures must be gathered in person from credentialed delegates at the Spring State Convention on Saturday, February 22nd beginning at 8:00am and returned to MDP Executive Director, Christine Jensen, by 12:45pm.

# VII. Voting

All eligible members of the Michigan Democratic Party who become successfully credentialed through the VOATZ electronic voting system are eligible to vote at the State Convention.

Voting on the Convention floor shall be by voice vote or unanimous consent or, when prescribed the Convention Rules, by an electronic ballot using the VOATZ electronic voting system. If only one person is nominated for a position, the candidate may be elected by unanimous consent.

In the event of a contested election, electronic ballots shall be available through the VOATZ electronic voting system to all credentialed delegates as outlined in the Convention Rules. Credentialed delegates in attendance may cast a ballot through a personal device (smartphone or tablet) or with tablets provided in the Convention Hall.

Only in-person voting shall be permitted at the State Convention.

# VIII. Proportional Voting System

A proportional voting system (by County or by fraction of County in multi-county Districts) shall be used in County and District Conventions and Caucuses and on the floor of the State Convention. T system used shall be in accordance with the State Party Directive on Proportional Voting.

# IX. Eligibility and Allocation of State Convention Delegates and Alternates

In order to vote at the State Convention, a person must satisfy the membership requirements and become properly credentialed as outlined in this Call.

#### A. Allocation

There shall be one State Convention vote for each 500 votes or major fraction thereof cast for the Democratic candidate for President in 2024 provided that no fraction of a County within a Congressional District shall be without a minimum of one vote.
